For me, wedding photography is not a mere dispassionate chronicle of events. What I do mean is that I find it to be inspiration and passion which inflames and stirs me up, consuming my entire energy, thoughts and attention. I approach each client and his needs individually and with equal devotion. The fact is that I often find it difficult to part with photos as if I were giving a part of myself.





And, I regret to say, with pleasure though, that this also proves to be the reason for which I do not undertake to perform more than 20 wedding orders during a year. Nevertheless, as you have certainly managed to find out, the offered package is extensive; whereas, the number of photos can be increased. I am equally emotionally involved for the entire time I spend working for you and, consequently, I do not divide my work into the stage of preparation, ceremony, greetings, outdoor scene or wedding.





You hire me for hours which I entirely devote to accurately capture the most important and most beautiful moments of your life. Since every single second of "This Day" is unparalleled, I do prefer to stay with you longer. What I need to mention is that, in order to encourage you to hire me within the fullest possible extent, if you decide upon a smaller number of working hours than proposed in a package, this will not have any effect on the price.

## MY OFFER

A) a price for photo documentary of the wedding ceremony, which includes 8 working hours until 21:00 at the latest, of which you receive 80 prints, totals **PLN 2950**.

B) a price for additional 4 working hours until 1:00 a.m. at the latest, of which you receive additional 20 prints (developed photos), totals **PLN 650**.

C) a price for 4-hour photo session on any other day (this refers, in case of orders outside Warsaw, to another day of photo documentary), of which you receive 20 prints (developed photos) totals PLN 1000 (option with photo documentary).

- Every single photo you receive is subject to the author's processing with the use of graphics software,
- On a general basis, photos are developed in the 15 x 22,5 format, on glossy paper, with a white frame, at a professional laboratory. For each print/developed photo, you will receive a JPG file prepared to develop prints.
- Should you decide upon the entire package (A+B+C), the price can be negotiated. A wedding appointment is finally booked once an advance payment of PLN 500 is made and a contract is signed. For orders outside Warsaw, I can offer only A+B and A+B+C package combinations.

## SELECTION OF IMAGES

You select images to be further developed in the form of prints out of: 200 (A package), 300 (A+B package), 350 (A+B+C package) photos at minimum, with the size of 500 pixels (long side), which are the so-called review-photos made available through website galleries after entering a unique password.

## NUMBER OF PHOTOS

The number of photos you receive in a specific package (80[A], 100[A+B] or 120[A+B+C]), may be increased for an additional fee of PLN 12 per print (including electronic version) and PLN 10 per electronic version, without a print. Should you decide upon a bigger package (more than 50 prints), the price is subject to negotiation.

## TRAVEL CHARGES

- no extra fees are charged for orders within Warsaw area;
- up to 100 km from Warsaw an extra fee of PLN 1 / 1 km;
- over 100km up to 300 km from Warsaw travel cost is PLN 1 / 1 km, plus cost of accommodation (PLN 100 per night), to be ensured or covered;
- over 300 km from Warsaw - the price is subject to negotiation.

## OPTIONAL

An additional working hour not covered by the scope of the contract + **250 PLN**

Preparation of an album + **400 PLN** (+ cost of album)

Presentation on a DVD + **200 PLN**

Internet gallery for 1 year + **200 PLN**
